

WAIVER TO PARTICIPATE IN STUDIO DANCE CLASSES 2019-2020

Please read and initial each statement.

1. \_\_\_\_\_ Enrollment and tuition fees are for one full dance season. A \$65.00 registration fee per dancer will hold the dancer's placement in the class. The registration fee is non-refundable after September 10th, 2019. All tuition is payable on the 15th of each month. Annual tuition payments are due September 15th, 2019. Semester tuition payments are due September 15th, 2019 and January 15th, 2020. **I understand tuition is based on enrollment, not on attendance.** A \$10.00 late fee will be added to accounts on the 20th day of the month for all unpaid tuition. A \$25.00 return check charge will be added to all unsupported payments.
  
2. \_\_\_\_\_ Grayce DeWitt Dance Studio takes every precaution to ensure your child's safety. As dance is a physical activity, injuries may occur. GDDS instructors and staff are not responsible for injuries occurring before during or after classes on the premises of the Grayce DeWitt Dance Studio, Park Plaza Shopping Center or the Alma Performing Arts Center.
  
3. \_\_\_\_\_ Grayce DeWitt Dance Studio instructors and staff are not responsible nor will be held liable for loss or damage of personal property.
  
4. \_\_\_\_\_ To officially withdraw from all studio classes, an official **withdrawal form** must be submitted to GDDS staff. Verbal withdrawal with an instructor is not sufficient. Tuition fees will compound should there be failure to withdraw properly. A **withdrawal form** not received two (2) weeks before the first week of classes in any given month will result in normal charge of tuition fees for that month. In the event it becomes necessary to file set to collect damages, I agree to pay a reasonable attorney fee and the cost of the collection.
  
5. \_\_\_\_\_ I understand and agree my checking account/debit/credit card will be debited on the 15th day of each month September 2019 through May 2020 for the total monthly tuition due. I understand and agree my checking account/debit/credit card will be debited on the 15th day of October 2019 for the costume deposit (\$75.00 per dancer). I understand and agree my checking account/debit/credit card will be debited on the 30th day of November 2019 for the costume balance due. I understand I must purchase a ticket (\$10.00 per ticket) from the Alma Performing Arts Center to attend the annual spring recital. I understand I am responsible for signing the award list between October 1st and April 3rd for my dancer to receive a 5, 10, or 15 year award or a graduating senior award.
