

WAIVER TO PARTICIPATE IN SUMMER DANCE ARTS 2020

Please read and initial each statement.

1. _____ I understand that enrollment and tuition fees are specific to Grayce DeWitt Dance Studio Summer Dance Arts classes and intensives. A \$10.00 registration fee per dancer will hold the dancer's placement in the class or intensive. The registration fee is non-refundable after June 16th, 2020 for all classes and Monday, June 29th, 2020 for the ballet intensive. Tuition for Summer Dance Arts classes is due on Tuesday, June 16th. Tuition for the Summer Dance Arts ballet intensive is due on Monday, June 29th. Tuition may be paid with credit card, debit card or check payable to Grayce DeWitt Dance Studio. **I understand tuition is based on enrollment, not on attendance.** A \$10.00 late fee will be added to accounts on the 18th of June (SDA classes) or the 30th of June (SDA ballet intensive) for all unpaid tuition. A \$25.00 return check charge will be added to all unsupported payments.

2. _____ Grayce DeWitt Dance Studio takes every precaution to prioritize the health and safety of our faculty, our students and their families. I understand and agree that participating in any dance lesson or class, workshop, intensive, rehearsal or performance, there is a possibility of physical injury. I voluntarily agree, therefore, to assume all risks and responsibility for any such injury or accident, which might occur to me (or my child) during any of Grayce DeWitt Dance Studio's classes, lessons, rehearsals, performances, or activities. I also exempt, release, and indemnify Grayce DeWitt Dance Studio, its owners, agents, volunteers, assistants, employees, guest artists, faculty members, and/or students from any and all liability claims, demands, or causes of action whatsoever from any damage, loss, injury, illness or death to me, my children, or property which may arise out of or in connection with participation in any classes or activities conducted by Grayce DeWitt Dance Studio. I further hereby voluntarily agree to waive my rights and that of my heirs and assigns to hold Grayce DeWitt Dance Studio, its owners, agents, volunteers, assistants, employees, guest artists, faculty members, and/or students liable for such damage, loss, injury, illness or death. I understand that I should be aware of my physical limitations and agree not to exceed them. If I am signing this waiver for my children, I certify that I am the parent or legal guardian and have the right to waive these rights.

3. _____ To officially withdraw from all studio classes, an official **withdrawal form** must be submitted to GDDS staff. Withdrawal forms are available at the dance studio's front desk. Verbal withdrawal with an instructor is not sufficient. Tuition fees will compound should there be failure to withdraw properly.
